#### I. Purpose

"Activity Period"

These Terms & Conditions are intended to formalize the rules by which the Activity will be conducted and the rules and conditions of participating therein.

By participating in the Activity, each Participant accepts as binding these Terms & Conditions, including all the conditions contained therein.

Participation in the Activity is exclusive responsibility of the Participant. Ferrero and/or anyone acting on its behalf, bears no responsibility for any damage which is caused and/or shall be caused to a Participant as a result of and/or in connection with his participation in the Activity.

As defined in Section II. 1. (a)-(d)

The following terms shall have the meaning ascribed to them:

"Participant" Any individual meeting the criteria set in Section II. 2., and participating in the Activity, all in accordance with these Terms & Conditions

"Proof of Purchase" Receipt(s) each corresponding to a minimum spending of €20 (or equivalent in local currency) on the products mentioned in Section II, 2c. to be uploaded on the "Ferrero branded Website" developed by TLC (as defined herein below) within 14 days from the purchase

"Credit(s)" a unity equivalent to €1 (or equivalent local currency) to be used on the TLC Travel Platform as defined herein below.

The platform is set in English Language.

# II. <u>Terms of Activity</u>

# 1. Activity Period

- a. The Activity follows different schedules in the different Duty-frees, each of them being the "Activity Period". Once the Participant will have received the Prize(s), he/she will be able to use the Prize until 31/12/24.
- In Paris Duty-Free, the Activity opens on 24<sup>th</sup> of June 2024 at 9:00 and closes 26<sup>th</sup> August 2024 at 23:59 a.m. European Time (exact dates and local TIME).
- c. The Activity will be advertised during the Activity Period in the Duty-Frees.

#### 2. Terms of Participation & Activity Mechanics

To Participate, Participants must:

- a. Agree with the Terms & Conditions
- b. Be 18 years old at least at the time of participation.
- c. Purchase a minimum amount of €20 (or equivalent in local currency) of any Ferrero product in the Duty-Frees and provide adequate Proof of Purchase.
- d. Within 14 days from the purchase, Participants must register and create an account (by entering the requested personal information as detailed in the Privacy Policy) on the Ferrero branded Website and upload the Proof of Purchase. These will be verified by TLC, who will proceed sending a code and a pin to the Participant in order to access TLC Travel Platform and redeem the Prize.
- e. Once the Participant, receives the code and pin by TLC, they must create a profile on TLC Travel Platform (the "TLC Profile")
- f. Using their TLC Profile, the Participant will be able to use the Prize in several hotel accommodations available on the TLC Travel Platform, until the last day as specified in Section II, 1 a. The number of Credits that are applicable to one single booking may

differ from facility to facility, as granted by each individual accommodation and according to the criteria decided by the customer such as, but not limited to: type of accommodation, dates of booking, and number of guests. The number of Credits that can be used in each individual accommodation are automatically displayed and applicable to the booking.

Are excluded from participating:
